DIRECTIONS FOR USE

Apply evenly over surfaces using a sprayer, foamer, brush, cloth, scrub pad or steel wool. For average deposits allow the cleaner to cling to the surface for two or more minutes. For heavier soils, allow ten minutes or more of contact time. On stubborn areas, rub with an abrasive pad or steel wool. Preheating the oven to 150-200°F will promote more rapid cleaning of burnt on soils. After cleaning, sponge surface to remove residues, and rinse with water.

NOTE: ALWAYS WEAR RUBBER GLOVES AND EYE PROTECTION WHEN USING THIS PRODUCT. NEVER SPRAY TOWARDS FACE OR EYES.
